Mayor Huntley called the meeting to order.

BUSINESS

Mayor Huntley administered the Oath of Office for appointed Councilmember Jackie Burch.

Council discussed a deer feeding ordinance. Almond presented council with the town's animal ordinance with a previously approved text amendment prohibiting feeding deer that was later removed from the ordinance. C. Council said a wildlife biologist advised in 2022 not to feed deer, and also said the text amendment was removed from the animal ordinance due to enforcement questions. Almond looked into a group hired to remove deer but the cost

was high with limited results. Ward said we need to encourage the state to have a controlled hunt in Morrow Mountain State Park.

Motion to adopt animal ordinance text amendment to not feed deer in town: C. Council
C. Council amended motion to draft a new text amendment that is agreeable to the council.

Discussion: C. Council and Rife will work on the draft text amendment, and council will hold two public hearings regarding the amendment.

Council discussed how to proceed with 85 Falls Road code enforcement after a representative for the property owner contacted town hall to request code enforcement be halted until legal proceedings between the property owner and insurance company are resolved. Almond said he and the code officer Matthew Rea agreed to delay further action until council rendered an official decision. Council consensus is to proceed with minimum housing code enforcement.

PUBLIC WORKS:

Miller reported the following:

- Next limb/brush collection January 6, 2025.
- 4 Loads of brush for December.
- Leaf pickup is ongoing.

Almond said public works will collect leaves on school streets each scheduled collection day due to heavier traffic. Ward says leaves should be collected there every week, citing close calls with vehicles trying to get through. C. Council said he was told by Eudy that every time the leaf truck runs they'll collect around the school. Almond suggested reminding citizens of the leaf schedule. Rife said we should remind the citizens of limb & brush collection schedule as well. Huntley said to use the RAVE system to do an all call.

POLICE REPORT:

- Chief Smith reported 1,853 calls for service in November.
- Uptick in domestic disturbances, fire & EMS calls are common in winter.
- The police audit went good.

Almond commended Chief Smith for the good audit report.

FINANCIAL REPORT:

Almond presented financial report ending December 5, 2025. November revenues from property tax, sales & use tax and occupancy tax.

MANAGER'S REPORT:

Almond reported the following:

1. Recognized 1976 North Stanly Women's Basketball Team.
2. Rife and Almond met with Badin VFD Chief Timothy Jarmon to discuss fire safety via public address, and posted an interview with Chief Jarmon on Facebook.
3. Rife will attend the Stanly County CVB meeting 8:30 a.m., Wed., Dec. 10.
4. Alcoa's quarterly Citizen Advisory Board (CAB) meeting will be 11:30 a.m., Dec. 11 in the 1913 Badin Inn.
5. Rife and Almond met Monday with members of Miles-McClellan Construction Company to discern project start date as well as other project restart and amenity purchase details. Rife noted a need to go back through county permitting.
6. Badin Town Hall will be closed Dec. 24-26 in observance of Christmas and Jan. 1-2 in observance of the New Year holiday.
7. The next Regular Council meeting will be 7 p.m., Jan. 13, 2025 in Badin Town Hall.

Almond explained what is happening next to Tho's Pizza & Hot Subs, formerly Bogan's radiator shop, and before that a fuel station. The state has funded the removal of three fuel tanks still underground. So far no fuel leaks found that would warrant further digging.

COUNCIL COMMENTS:

Ward said there is a manhole spacer ring busted on Hickory St. He called the county and they have ordered a spacer. Cardboard boxes on Willow St. should be collected. He complimented Better Badin on tree lighting. Also street light is out in front of antique shop.

Rife reported a crushed drain pipe at Falls Rd. and Stanly St. The utility pole in West Badin Park is leaning and needs straightening.

C. Council welcomed Jackie Burch to the council. He mentioned Red & Blue Christmas this past weekend, and recognized Polly Martin for putting the event together. He thanked Ward for school crosswalk service.

Huntley said Tyler Thompson of Thompson Auction was in town this morning to take pictures and offered to move everything to his shop for the auction. He asked Almond what needs to be done for the Arts Council Banner contest. Almond said we just need to send measurements. He suggested setting a work session for new council member Jackie Burch.
